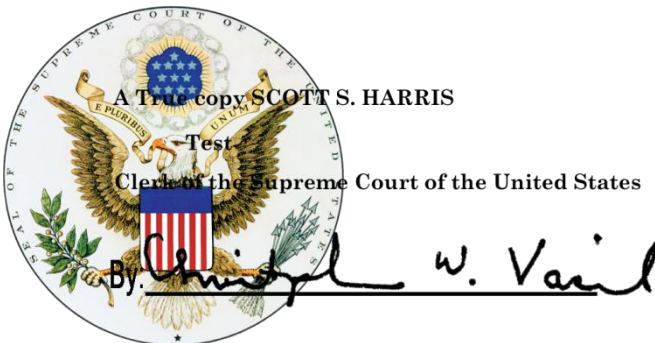

STIPULATION OF DISMISSAL


